

## ORDINANCE 2155

### AN ORDINANCE AMENDING CHAPTER 132, OF THE MUNICIPAL CODE OF THE CITY OF ANKENY, IOWA

---

**WHEREAS**, the City Council of the City of Ankeny, Iowa, deems it necessary and proper to amend Chapter 132, of the Code of Ordinances to match current standards and practices for use of Multi-Use Recreational Trails.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANKENY, IOWA:**

**Section 1:** That Chapter 132, Peddlers, Solicitors and Transient Merchants, be and is hereby amended delete the stricken language and to include the underlined language:

#### **132.02 DEFINITIONS.**

For use in this chapter the following terms are defined:

1. “Peddler” means any person carrying goods or merchandise who sells or offers for sale for immediate delivery such goods or merchandise from house to house, ~~or upon the public street~~ or Multi-Use Recreational trails. An ice cream truck is considered a peddler unless it contains a mobile kitchen and facilitates the preparation, marketing and sale of food that is whole and unprocessed, packaged, or prepared in which case the ice cream truck is considered a Mobile Food Vendor subject to Municipal Code Chapter 142.
2. “Solicitor” means any person who solicits or attempts to solicit from house to house, ~~or upon the public street~~ or Multi-Use Recreational trails any contribution or donation or any order for goods, services, subscriptions or merchandise to be delivered at a future date. The definition of "solicitor" also includes any person engaged in the business of bill posting.

**132.18 PEDDLERS OPERATING UPON STREETS.**

No peddler shall sell or offer for sale upon the public right-of-way any goods or merchandise for immediate delivery unless such vendor complies with the conditions set forth in this section.


3. Stopping for Delivery Prohibited; Sales on Streets or in Parks or on Multi-Use Recreational Trails Prohibited. No person operating a vehicle (peddler's ice cream truck is exempt) may stop for the purpose of delivering goods or merchandise on the paved portion of the public right-of-way. In no event shall sales be permitted on any collector or arterial street within the City or within any public park or Multi-Use Recreational trail.



**Section 2:** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**Section 3:** This ordinance shall be in full force and effect after its passage, approval and publication as provided by law.
